

Terms of Service:

User Qualifications:

1.1. Individuals must be at least 18 years old to use the App unless parental consent is obtained.

1.2. By operating the App, you assure that you possess the legal capacity to adhere to this Agreement.

License and Intellectual Property:

2.1. The Provider bestows upon you a restricted, non-exclusive, non-transferable license to use the App and its features strictly for personal, non-commercial utilization.

2.2. The App, along with its content including but not restricted to text, graphics, logos, and software, is safeguarded by intellectual property laws, and remains the property of the Provider or its licensors.

User Responsibilities:

3.1. You consent to use the App in accordance with applicable laws, regulations, and this Agreement.

3.2. You are prohibited from engaging in any illegal, harmful, or disallowed activities while utilizing the App, such as:

Transmitting or uploading malicious code or viruses, or any content that might disrupt or damage the App or its users.

Infringing on others' privacy rights or gathering personal information without appropriate consent.

Impersonating any individual or entity or providing incorrect information.

Privacy and Data Collection:

4.1. The Provider collects and processes your personal data in compliance with the App's Privacy Policy, which can be accessed at www.lexhelp.es or www.lexhelpapp.com.

4.2. By using the App, you give your consent to the Provider's collection, usage, and disclosure of your personal data as detailed in the Privacy Policy.

User-Generated Content:

5.1. If the App allows you to create or submit content, you retain any intellectual property rights in said content.

5.2. By creating or submitting content, you provide the Provider with a worldwide, non-exclusive, royalty-free license to employ, reproduce, alter, adapt, publish, translate, distribute, and exhibit the content within the App and for promotional purposes.

Dispute Resolution:

- 6.1. Any disputes deriving from or relating to this Agreement should be resolved through negotiations in good faith.
- 6.2. If the dispute cannot be settled through negotiation, it shall be referred to the Courts of Barcelona (Spain).
- 6.3. Spanish law shall govern this Agreement, without considering its conflict of law provisions.

Limitations of Liability:

- 7.1. The Provider is not liable for any direct, indirect, incidental, consequential, or punitive damages arising from or related to the use of the App.
- 7.2. The Provider does not guarantee that the App will be error-free, uninterrupted, or secure, and disclaims any liability for any errors or omissions in the App's content or functionality.

Updates and Modifications:

- 8.1. The Provider reserves the right to update, modify, or terminate the App or this Agreement at any time without providing prior notice.
- 8.2. By continuing to use the App following any changes, you consent to adhere to the updated terms and conditions.

Termination:

- 9.1. The Provider reserves the right to terminate this Agreement or suspend your access to the App at any time without providing prior notice if you breach any provisions of this Agreement.
- 9.2. Upon termination, your right to use the App will end, and any provisions of this Agreement that should reasonably survive termination will remain in effect.
